THIS COURT ORDERS that:

- 1. The Respondent, Rhonda Hiebert, personally, and Rhonda Hiebert carrying on business as Pampered Pets Ultrasonic, until such time as she becomes a member in good standing of the College, be permanently prohibited and enjoined from:
 - (i) holding herself out as engaging in the practise of veterinary medicine;

- (ii) making an offer to do anything that connotes or implies that she is engaged in the practice of veterinary medicine;
- (iii) making a representation that she is qualified or entitled to do or engage in the practice of veterinary medicine for or in the expectation of a fee, gain, or reward, direct or indirect, from the person for whom the acts are performed; and
- (iv) representing or holding herself out as a veterinarian or in any other manner that implies or connotes that she qualified or entitled to engaged in the practise of veterinary medicine including veterinary dentistry.
- 2. By January 31, 2020, the Respondent will delete from her website and other promotional materials the following words and phrase that implies or connotes that she qualified or entitled to engaged in the practise of veterinary medicine including veterinary dentistry:
 - (i) canine, feline oral hygiene specialist;
 - (ii) canine dental chart;
 - (iii) dental care;
 - (iv) ensure any infections are cleared up;
 - (v) heal infection;
 - (vi) your pet's health is our concern;
 - (vii) proper oral health care;
 - (viii) comprehensive oral health care;
 - (ix) like getting our teeth cleaned at the dentist;
 - (x) oral care;

- (xi) Good oral care can help your pet live a longer and healthier life; and
- (xii) Just like humans most domesticated pets need professional scaling.
- 3. Costs as agreed to in the amount of \$1,500.00.
